



Dear Parent/Guardian,

As new technologies continue to change the world in which we live, they also provide many new and positive educational benefits for classroom instruction. Therefore, here at Sand Pine, we have implemented the Bring Your Own Device (BYOD) program. In this initiative, students are encouraged to bring their own technology devices to school to assist their learning experiences. This document is a contract to which we will adhere as we establish this new program within our school.

Definition of “Device” For purposes of BYOD, “Device” means privately owned wireless and/or portable electronic hand-held equipment. The device should be portable and used for word processing, reading, wireless Internet access, image capture/recording, and sound recording and information transmitting/receiving/storing.

Security and Damages Responsibility to keep the device secure rests with each student. Pasco County Schools will not be held liable for any device stolen or damaged while on our campus. If a device is stolen or damaged, it will be handled through the administrative office similar to other personal artifacts that are impacted in similar situations. It is recommended that skins (decals) and other custom touches be used to physically identify your device from others. Additionally, protective cases for technology are encouraged.

BYOD Student Agreement The use of technology to provide educational material is not a necessity but a privilege. When respected, they will benefit the learning environment as a whole. Students and parents/guardians participating in BYOD must adhere to the Student Code of Conduct as well as all Board policies, particularly Internet Acceptable Use and Internet Safety. Furthermore, the student must agree to the following conditions:

The district is not responsible for the security of student-owned technology. 	<ul style="list-style-type: none"> The device must be in silent mode while on school campuses and while riding school buses.
<ul style="list-style-type: none"> The student accesses only files on the device or Internet sites, which are relevant to the classroom curriculum. 	<ul style="list-style-type: none"> The student complies with teachers’ request to shut down the device or close the screen.
<ul style="list-style-type: none"> The student will follow all school rules and laws when using electronic devices at school. *Please reference the Student Code of Conduct on our school website. 	<ul style="list-style-type: none"> The student will understand that their teachers and administrators have the right to access whatever they do online while in school if they are concerned about student safety or the safety of others.
<ul style="list-style-type: none"> The student does not have an absolute right to take, publish, and post photographs or videos of others at school, as it may impact their individual rights to privacy. 	<ul style="list-style-type: none"> The student will only use the school network to access information while on school grounds.
